Agency for Healthcare Research and Quality (AHRQ) CAHPS® Database De-Identified Research Dataset Contents

This document is for individuals interested in requesting de-identified CAHPS data from the AHRQ CAHPS Database and shows the contents of the de-identified research datasets.

The Consumer Assessment of Healthcare Providers and Systems (CAHPS®) Database is a central repository for CAHPS survey data. The CAHPS Database is funded by the Agency for Healthcare Research and Quality (AHRQ), and managed and administered by its contractor, Westat.

The CAHPS Database is populated with CAHPS data through the voluntary participation of organizations that have administered a CAHPS survey and are willing to submit their CAHPS data for inclusion in the Database. Research datasets contain de-identified Database data from the CAHPS Health Plan Survey, CAHPS Clinician & Group Survey, CAHPS Hospital Survey, CAHPS Home and Community-Based Services Survey, and CAHPS Child Hospital Survey.

Table 1 shows the content of each CAHPS de-identified research dataset, including information on the survey items, site characteristics, and ID variables included in each dataset. Dataset names for each setting contain hyperlinks to survey websites.
