Review charts until *90 eligible people* are identified for each time point (check summary page for totals)

1. Did this patient have a face to face visit with an enrolled provider in the year prior to measurement date?
$\square$ No - Exclude from review record denominator $=0$ and begin review of next chart
$\square$ Yes - Continue
2. Is patient $\geq 181$ year prior to measurement date AND <=85 as of 1 year prior to measurement date?
$\square$ No - Exclude from review record denominator $=0$ and begin review of next chart
$\square$ Yes - Continue
3. Was the patient diagnosed with essential hypertension* on the active problem list by 6 months prior to the measurement date or has an office visit diagnosis code by 6 months prior to measurement date?
$\square$ No - Exclude from review and begin review of next chart
$\square$ Yes - Record as Denominator = $\mathbf{1}$ and continue

## Part 3: Determine if this chart meets numerator criteria.

1. Find most recent *office recorded* BP in a standard EHR field within 1 year prior to measurement date. Is the systolic BP $<140$ and diastolic $\mathrm{BP}<90$ ?
$\square$ Yes - Meets criteria for Numerator , record = $\mathbf{1}$ and begin review of next chart
$\square$ No - Blood pressure is higher. Continue to determine if exception (X) exists
$\square$ No - Blood pressure is not measured record numerator $=\mathbf{2}$ and begin review of next chart

## Part 4: Determine if chart meets exception criteria

1. Is there a dx code on the active problem list (on or before MeasDate) or an office visit dx code (on or within 1 year before MeasDate)

## indicating pregnancy*?

$\square$ Yes - Meets criteria for Exception, record numerator=2 and move to next chart
$\square$ No - Continue with review to determine if another exception exists
2. Is there a dx code on the active problem list (on or before MeasDate) or an office visit dx code (on or within 1 year before MeasDate) indicating end stage renal disease (ESRD)*?
$\square$ Yes - Meets criteria for Exception, record numerator=2 and move to next chart
$\square$ No - Continue with review to determine if another exception exists
3. Does the chart indicate that the goals of care are palliative?
$\square$ Yes - Meets criteria for Exception, record numerator=2 and move to next chart
$\square$ No - Doesn't meet exceptions, record numerator $=0$ (uncontrolled BP) and move to next chart
